- A: The orientation does not need to be completed again if the individual is a minor. However, if the prospective SDP candidate is an adult, participation in an SDP orientation is required.

- WRC will be collaborating with FMS community to coordinate efforts and address rate changes.

- WRC currently has no 099 providers; however, WRC aims to vendor providers in the next months. WRC hosts a Monthly Independent Facilitator Round Table where 099 is discussed. ## DVU \& Claudia Cares RFP

- Claudia Cares

- Q: Are the FMS Rate changes discriminatory? If you don't speak English, why do you have you have to pay more? I am concerned that now families have to pay more.
- A: FMS Fees will not be paid out of the participant budget. Rate increases will support FMS in providing services to all individuals by addressing staffing issues. FMS are also eligible to become vendored under 099 to receive additional funding in support of individuals transitioning into SDP.

- Q: Have any FMS completed vendorship for 099? What should Spending Plans look like following the FMS rate increases?
- A: FMS's have started process to complete vendorship. However, FMS must complete vendorship with their home Regional Center. Once completed, WRC may provide courtesy vendorship. Participant Spending Plans should identify and itemize each employee, service, resource, etc. WRC will collaborate with FMS community to reduce any negative impact on participant experience.
