WRC Update

Cesar Garcia presented the following data about SDP participants at Westside Regional Center:

- -278 total people in SDP
- -Majority English speaking (258 individuals)
- -Majority male (192 individuals)
- -Majority 13-22 years of age (104 individuals)
- -Majority from Los Angeles (129 individuals)
- -Majority are White/Caucasian (131 individuals)
- -Average budget by ethnicity: highest is Japanese (a little under \$250,000) and second is Native American (\$200,000)
- -Average budget overall is a little over \$100,000

A discussion was had by Committee members about this data and possible factors not captured in these numbers, including using median instead of average, and how best to capture languages spoken.

Alex Marquez presented the following update about SDP at Westside Regional Center:

Orientations

12 part 1 orientations completed in November. 9 registered so far for part 2 in November. 9 completed part 2 orientations completed in October. 13 SDP transitions in October, 8 in November, and 6 already for December.

Barriers to Transition

- -Not enough FMS'. 1 new FMS vendor, named Action FMS, has been added recently.
- -Insufficient amount of Independent Facilitators. Only 2 099 IF providers so far, but there are many outside WRC catchment area who are trying to get vendored with home RC and then courtesy vendored with WRC.

Monthly SDP Meetings

- -Independent Facilitator Roundtable continues to be the first Wedesday of every month.
- -WRC has started a new Spending Plan Workshop, every 4th Friday of the month. 8 attended the first one and got technical guidance for the spending plan.

Review of Motions From Last Meeting

Alex Marquez provided the updates.

1st **Motion**: Recommend WRC to put policy in place for automatic rate increases.

Update: WRC conncected with DDS for guidance, and DDS said that when reviewing rate increase, WRC has to assess for the need for the increase.

2nd Motion: Recommend that spending plans get approved without consideration of cost effectiveness. **Update**: WRC connected with DDS for guidance. WRC' best practices will include assessing a requested service with inclusion of cost effectiveness consideration.

Public Comment

E.B.-having issue with SDP process with WRC. Feels program overall is excellent, but there are too many barriers.

M.A.-Thanks Cesar for the data presentation. Suggests tracking the age data from when they entered SDP not now. Ethnicity data should be compared to overall % of regional center population. Has issues with the clinical services process in SDP at WRC.

A discussion is had between Committee members and Cesar Garcia about the progress report process in SDP at WRC.

Small Work Group Update

Alex Marquez informs the committee about what was discussed at the small work group about the progress report template. Guidance was given at the meeting about how the template would be completed and who needs to complete it.
